聯合再生能源 2019 年 1-6 月累計合併營收破新台幣 100 億元

年增 86.7%

聯合再生能源(3576 TT)今日公告其 2019 年 6 月份自結合併營收為新台幣 13.9 億元，較去年同期成長 32%。

聯合再生能源全年累計至六月合併營收為新台幣 100 億元，較去年同期新台幣 53.6 億元增加 86.7%。6 月營收較 5 月下降主因受台灣雨季影響，案場模組安裝進度延遲，導致客戶遞延拉貨。另外，除了對外銷售外，聯合再生亦開始為年底數個大型案場開工做備貨準備。聯合再生已轉型以模組品牌與下游太陽能系統業務為主，未來模組及太陽能系統事業將對公司營收動能有顯著的貢獻。

United Renewable Energy Announced 2019 January to June Accumulated Revenue of NT\$10,000 Million with 86.7% growth YoY

United Renewable Energy (“URE”, or “the Company”, 3576 TT), announced June 2019 revenue of NT\$1,395 million, a significant jump of 32% YoY.

The Year-to-Date cumulative revenue reached NT\$10,000 million as of June 2019, a 86.7% increase in YoY terms as opposed to NT\$5,360 million of year 2018. There is delayed shipment due to the postpone module installation in customer’s system projects due to Taiwan monsoon season, and URE is preparing stocks for construction of several large system projects which is due to start at end of the year. URE will continue to expand the solar module and system business which will, in turn, drive the future revenue growth of URE.
